## **DIRECTIONS FOR USE**

**Irrigation Injection Applications:** inject 1-2 quarts per acre every 7-10 days.

**Spray applications:** Apply 2-4 quarts per acre every 7-10 days.

## **GENERAL RECOMMENDATIONS**

Make the first application at the maximum labeled rate followed with maintenance applications every 7-10 days thereafter or as needed. PENETRAIDE PRO™ does not need to be watered in. PENETRAIDE PRO™ may be tank mixed with other commonly used inputs. If unfamiliar with a new tank mix, prior to application, evaluate the tank mix for compatibility and apply to a small area to determine the effect on turf quality.
