DIRECTIONS FOR USE

Standard Unit - 100 gal tank– Mix weekly supply of "Standard Unit" microbial blend with water into 100 gal tank.

For initial microbial colonization: Inject 10-20 gals per 1 treated acre, weekly for 1st month.

For program maintenance: Inject 5-10 gals per 1 treated acre, weekly.

*Fairways - program maintenance: Inject 2 gals per 1 treated acre, weekly.
